Excerpt of the minutes of the council meeting held on Monday, February 15, 2021

1b Question Period and Receipt of Petitions

1. A resident of McNicoll Crescent asks: 1) why the assessment reports submitted to the **Demolition Committee** are not accessible via a hyperlink in the demolition public notices, as is done by the City of Pointe-Claire; 2) for a follow-up on the City's acquisition of the former **Château Dorval** restaurant site; and 3) why the municipality would not adopt a strategy applicable to future developers that would aim to implement **affordable housing**.
2. A resident of Allard Avenue requests that a plaque erected on a municipal building mentioning a **former city councillor** (now deceased) be removed due to a criminal act he allegedly committed in the 1970s.
3. A resident of Parkfield Avenue asks that the grounds behind the **Surrey Aquatic and Community Centre** be developed into a park and requests that the City put a fence around the dog park to ensure the safety of residents walking there.
4. A resident of Handfield Circle asks if the property that burned down on **Handfield Circle** will be rebuilt and, if so, whether the plans for the new property will be made public.
5. A resident of chemin du Bord-du-Lac—Lakeshore asks: 1) why the fence that obstructs the view of drivers at the corner of chemin du **Bord-du-Lac—Lakeshore and Lepage** is still there and why the City does nothing to ensure people's safety; 2) why Murray Levine's **election signs** were removed twice by the City in 2017; and 3) why the City allowed the **FTQ signs** to remain displayed for five months but was not as tolerant of Murray Levine's signs.
6. A resident of Saint-Charles Avenue asks: 1) to know the details of the ownership transfer of **252 Clément**; 2) if Mayor Rouleau has ever been warned by the director general or public security that he was in violation of the snow removal by-law, because the snow on his property appears to have been pushed onto public property; and 3) why **Councillor Heron** broke municipal regulations a few years ago by building a residence in her backyard.

7. A resident of chemin du Bord-du-Lac—Lakeshore asks: 1) whether, during the 2017 elections, a person in authority saw the **election signs** before they were removed and how much time elapsed between the moment they were seen by an employee and the moment they were removed; 2) why the City waited 5 months to remove the **FTQ signs** while his sign was removed within an hour; and 3) why municipal employees allowed the FTQ signs to remain on public property for at least 20 weeks.
8. A resident of Mimosa Avenue asks: 1) why the City is working with a **soccer association** that does not target all ages and skill levels; 2) whether an audit was carried out following the loan that the City gave to the **Dorval Athletic Association**, which was then given to the Dorval Soccer Association, and whether the money was paid back to the City; and 3) why the **Dorval Soccer Association** received taxpayers' money when it is an NPO bound by a service contract with the City, which charges fees to its members and uses the City's fields for free.
9. A resident of Prince Charles Avenue asks: 1) what the **financial impacts of COVID-19** are on the City's revenues and whether these impacts were accounted for in the budget; 2) what the financial impacts of COVID-19 are on the City's non-profits; and 3) if financial support measures are being considered by the City.
