Excerpt of the minutes of the council meeting held on Monday, March 15, 2021

## **CM2103 083**

### **1b Question Period and Receipt of Petitions**

1. A resident of Pine Beach Boulevard asks whether it is possible to amend the municipal by-law to extend the validity period of an authorization certificate for a temporary car shelter until April 30.

2. A resident of chemin du Bord-du-Lac—Lakeshore asks if the City could implement a recycling program aiming to install recycling bins for disposable procedure masks.

3. A resident of Saint-Charles Avenue asks: 1) why, for several years, Mayor Rouleau has been tolerating Councillor Heron's violation of municipal by-laws by building a structure in her backyard; 2) why the council accepts that the buyer of the land situated at 252 Clément does not comply with the conditions set out in the original deed of sale, and breaches the contract by transferring the property to his son; and 3) if he can publicly release his personal audio recordings of council meetings, created before the City made its recordings public on its website as of October 2019.

4. A resident of chemin du Bord-du-Lac—Lakeshore asks: 1) if the City will continue its live webcasts once the COVID restrictions have been lifted; 2) for a follow-up on the status of the plan to build affordable housing on the site of the Elizabeth-Russell Centre; and 3) whether the City will develop a second community garden to serve residents living in the south of Dorval.

5. A resident of Chanteclerc Avenue, on her own behalf and that of 5 other citizens who are members Technoparc Oiseaux and/or Regroupement Québec Oiseaux, asks: 1) when the mayor will respond to the letter asking for Golf Dorval to be open for winter activities from mid-December to mid-March to allow sports and observation of the wide variety of bird and owl species found there; 2) how the council responds to this request; 3) when the mayor would be available for a meeting with representatives of both groups.

6. A resident of McNicoll Crescent asks: 1) why, at the previous council meeting, her question about whether the City could trade land for affordable housing when selling to developers was altered when it was read; 2) how such a practice does not constitute an abuse of process at a time when the City does not allow the public to ask questions directly, as it would be possible via the Zoom platform; and 3) to strike her question relative

to affordable housing from the minutes of the council meeting held on February 15, 2021, as it is not the question she asked, and to record the reason for doing so in the minutes of the March 15, 2021 meeting. (The Mayor now reads the resident's integral third question addressed at the council meeting held on February 15, 2021.)

7. A resident of chemin du Bord-du-Lac—Lakeshore asks: 1) who wrote up the offer to purchase the McConnell property 3 years ago, and what expertise this person had in composing such an offer; 2) what the City intends to do to direct Tour de France cyclists onto the Dawson Avenue cycling paths and away from chemin du Bord-du-Lac—Lakeshore; and 3) whether it is possible to organize weekend festival/sales events on the grounds of the former Château Dorval restaurant, as is done in Sainte-Anne-de-Bellevue.

8. A resident of chemin du Bord-du-Lac—Lakeshore asks: 1) that the City make resident safety a priority by ensuring that cyclists and motorists circulate on public roads free of obstacles that could obstruct their vision; 2) why, during the 2017 municipal election, a City employee took a photo of a candidate's sign and which other signs were photographed; and 3) the name of the fishing lodge where Mayor Rouleau and his wife go fishing.
