Excerpt of the minutes of the council meeting held on Monday, May 17, 2021

## CM2105 173

### 1b Question Period and Receipt of Petitions

1. A resident of chemin du Bord-du-Lac – Lakeshore asks if the City could set up separate collection bins for **glass recycling** and whether she could obtain the contact information of an official from the agglomeration or provincial government.

2. A resident of de l'Académie Avenue, representing the joint ownership property situated at 200 de l'Académie Avenue, shares her concerns with regards to the project to **build a small farmhouse** at Collège Ste-Anne and apprehends the smells and noise generated by these animals. She wishes to take note of the exact plans and locations of these future developments.

3. A resident of Caledonia Avenue asks: 1) whether the council can consider authorizing the **parking of recreational vehicles in driveways** in the same manner as the tiny house located on a councilor's property in the event that it is maintained; and 2) if the municipality could lose its **bilingual status** due to Bill 96.

4. A resident of Dahlia Avenue requests that **washrooms** be accessible in parks (St-Charles, Millennium, and Pine Beach) and notes that she had made this request previously to no avail.

5. A resident of de l'Académie Avenue states: 1) that following the addition of parking zones on **Bouchard Boulevard, the use of bicycles** on this path is suicidal and asks the municipality to intervene to facilitate cycling in the area; 2) to anticipate **parking standards on de l'Académie Avenue** in order to restrict the use of the street by parents picking up their children at Collège Ste-Anne; and 3) that citizens in the area be informed about the **construction projects at Collège Ste-Anne**.

6. A resident of Vinet Avenue asks: 1) to restrict the hours of use of **lawnmowers** on weekends as already provided for in the regulations for leaf blowers; 2) to control and relocate the **increased presence of hares** on the territory; and 3) whether the use of a **wood-burning** appliance is prohibited by the City's by-laws.

7. A resident of St-Charles Avenue: 1) asks if the **Director General** encouraged the citizen who addressed comments and questions about him during the April council meeting; 2) states that the contract for the **sale of the lot situated at 252 Clément** should have had

a termination clause in the event that a home was not built on this land within a reasonable time frame; and 3) asks **Councilor von Roretz** if, as an independent candidate, his loyalty lies with the mayor or with the citizens of Dorval.

8. A resident of de l'Académie Avenue asks: 1) if the municipality approved the plans for the **construction of a small farmhouse** on the grounds of Collège Ste-Anne; 2) whether the council could **reconsider the establishment** of a small farmhouse near a residential area.

9. A resident of McNicoll Avenue asks: 1) if the City could install **urban facilities** in parks where there are none and increase the number of tables and **toilets in various parks**, particularly larger ones such as Millennium Park as well as Jean-Paul Bernier, St-Charles, etc.; 2) if the municipality plans to install **new splash pads in other parks** given that the existing ones are already being used at maximum capacity; and 3) what the **ADM's development plans** are for the north-east sector of Golf Dorval and why the City does not acquire it for use as a park.

10. A resident of chemin du Bord-du-Lac – Lakeshore asks: 1) whether the mayor could call upon the provincial government so that future mayoral candidates could undergo a voluntary **IQ test** for municipalities with a population of 19,500 inhabitants or more; 2) if the false rumors stating that he receives money for visits to his **blogs** could stop; and 3) that citizens should be able to decide whether they comply with City **by-laws** considering that the council authorizes the maintenance of the small house located on Councilor Heron's property.

11. A resident of St-Louis Avenue asks: 1) if the work under the **viaduct at the roundabout** will soon be completed; and 2) if the **dilapidated fence at the Pine Beach exit** along Highway 20 will be replaced.

12. A resident of de l'Académie Avenue points out several irritants resulting from the **construction work at Collège Ste-Anne** and asks if the City can intervene to reduce these irritants and improve the quality of life of neighboring citizens.

13. A resident of Neptune Boulevard asks if the municipality intends to return to **in-person council meetings**.
