Excerpt of the minutes of the council meeting held on Monday, August 23, 2021

1b Question Period and Receipt of Petitions

1. A resident of Oakville Avenue asks if the fence between Herron Road and Highway 20 will soon be replaced.
2. A resident of chemin du Bord-du-Lac—Lakeshore thanks the councillors for attending the Table de Quartier Community Council on affordable housing and asks if the City intends to form a committee or working group which could be mandated to look into ways to better implement affordable housing in Dorval.
3. A resident from chemin du Bord-du-Lac—Lakeshore asks: 1) if the City can intervene with ADM so that more planes can take off from the north runway rather than the south runway in order to allow for a better distribution of take offs and thus reducing noise pollution in the neighborhood; and 2) if the City could set a fund for the acquisition of waterfront land so that residents, through donations, could contribute to the purchase of green spaces.
4. Residents from Racine Avenue ask if the City could add to the brick wall separating the Public Works' yard from their backyard, to make it higher so that it could stop the dust and noise from bothering them.
5. A resident from chemin du Bord-du-Lac—Lakeshore asks: 1) if the City plans on intervening so that hedges not obstruct the visibility triangles within the Municipality; 2) asks councillor Le Sage why he did not inform him on the follow-up of his request concerning the visibility triangle corner chemin du Bord-du-Lac—Lakeshore and Roy; 3) to know the cost breakdown of contract LC 2021-03 concerning the supply and installation of five (5) swings in three (3) parks.
6. A resident from McNicoll Crescent thanks the councillors for attending the Table de Quartier Community Council on affordable housing and asks for clarifications of items 4 m), 4 n), and 6 a) published in the agenda (the Holiday Market and the municipal officials or officers to act as local metropolitan inspectors).

7. A resident from Saint-Louis Avenue 1) suggests that citizens be informed of the visit of the CP Holiday Train in Dorval; and 2) requests clarification pertaining to item 2 b) drinking water fluoridation.

8. A resident from Cloverdale Avenue thanks the City for the efficiency with which the demolition of the old Château Dorval restaurant was done and asks to know the schedule of the work and the plans of the future project.

9. A resident from St-Charles Avenue asks: 1) to Mayor Rouleau what bad decisions he has made during his term, including contesting the construction of Batshaw, and how much green space he has sold during his term; and 2) to councillor von Roretz why he supports the Jardins Dorval project.
