1.2 Question Period and Receipt of Petitions

1. A resident of chemin du Bord-du-Lac–Lakeshore raises questions concerning the **litigation** between him and the City of Dorval.
2. A resident of Dahlia Avenue raises questions about the relocation of the **CPE À Petits Pas**.
3. A resident of Tremont Avenue files a petition to oppose the opening of the **fence on Boylan**.
4. A resident of Tremont Avenue suggests that Council consider the negative impacts of opening the **fence on Boylan**.
5. A resident of Tremont Avenue raises questions regarding the **fence on Boylan** and suggests that studies be done before taking a position.

(With the mayor's agreement, councillors Pascal Brault and Paul Trudeau take turns speaking to answer the citizen).

6. A resident of Boylan Avenue raises questions regarding the **fence on Boylan** and points out the existence of a possible conflict of interest on the part of Councillor Brault who is an employee of Collège Sainte-Anne.
7. A resident of Tremont Avenue asks questions regarding the **fence on Boylan**, raises negative impacts that could result from its opening and demands that Collège Sainte-Anne intervene.
8. A resident of Boylan Avenue raises questions about the **fence on Boylan** and deplores the fact that Collège Sainte-Anne does not act to ensure the safe travel of children by bike.
9. A resident of Boylan Avenue asks questions regarding the **fence on Boylan** and asks for a permanent solution to prevent it from being opened.
10. A resident of Louise-Lamy Avenue asks questions about the **alternative house**.



11. A resident of Boylan Avenue asks questions regarding the **fence on Boylan** and asks Council to pass a resolution to permanently prevent its opening.
12. A resident of Tremont Avenue addresses Councillor Brault to indicate that the majority of the population concerned opposes the opening of the **fence on Boylan**.
13. A resident of Dorval Avenue asks questions about public **parking** in Dorval.

14. A resident of Handfield Circle asks questions regarding the **bike path on Bouchard Avenue**.
15. A resident of Place Picard asks questions about the **master plan for the cycling network**.
16. A resident of Neptune Avenue asks questions regarding: 1) the stone walls of the **McEachran Estate**; 2) **St-Charles Park**; and 3) the study on the condition of the building of the "**Quatre-Vents**" residence.
17. A resident of Martin Avenue asks questions about **St-Charles Park** and the redevelopment works.
18. A resident of 5th Avenue asks questions regarding: 1) the detour of the **bike path** at the corner of Dawson Avenue and Dorval Avenue; 2) the bike path on chemin du Bord-du-Lac–Lakeshore; and 3) the school corridor at **école Gentilly**.
19. A resident of Handfield Circle asks questions regarding: 1) the condition assessment of the property at **Sarto-Desnoyers Community Centre**; 2) the breakfast for the **Seniors Club**; and 3) the **monarch field**.
20. A resident of Saint-Charles Avenue asks questions regarding: 1) his **access to information requests**; 2) the **By-law RCM-95-2023 concerning the imposition of a contribution to finance all or part of an expense related to any addition to or enlargement or alteration of municipal infrastructures or equipment**; and 3) the **awarding of municipal contracts**.
21. A resident of Mousseau-Vermette Avenue asks questions concerning: 1) the **refrigerated skating rink**; 2) the **By-law RCM-60-PU.1-2017 amending the urban master plan**; and 3) **affordable housing**.
22. A resident of Lilas Avenue asks questions about **childcare services** during the summer.
