## **1.2** Question Period and Receipt of Petitions

- 1. A resident of Lepage Avenue asks questions regarding: 1) school bus transit in winter and construction on **Lepage** Avenue; 2) **bicycles** on chemin du Bord-du-Lac-Lakeshore; and 3) thanks the council for **St-Charles Park**.
- 2. A resident of Pointe-Claire inquires about criminal record checks.
- 3. A resident of Boylan Avenue inquires about: 1) professional services for the preparation of plans and estimates for the **demolition and reconstruction** of the Dorval Aquatic and Sports Complex's roof; and 2) the renovation of the **Ballantyne swimming pool**.
- 4. A resident of Roy Avenue asks a question regarding the refrigerated outdoor rink.
- 5. A resident of de l'Église Avenue asks a question regarding the installation of a **community fridge**.
- 6. A resident of St-Charles Avenue inquires about: 1) traffic and parking at the end of **St-Charles**; and 2) **Pointe-Picard** marina.
- A resident of Dawson Avenue asks questions regarding: 1) road conditions and the danger to cyclists; 2) affordable housing; and 3) speed bumps at Jean-Paul Bernier Park.
- 8. A resident of Notre-Dame-de-l'Île-Perrot inquires about **Zoning by-law infraction**.
- 9. A resident of Neptune Avenue inquires about: 1) the stone walls of the **McEachran estate**; and 2) a study on the condition of the **"Quatre Vents" residence** building.
- 10. A resident of McNicoll Crescent asks questions regarding the **shores of Lake Saint-Louis** and the implementation of the recommendations of the Truth and Reconciliation Commission.



- 11. A resident of Vaudreuil-Dorion inquires about carbon black nanoparticles.
- 12. A resident of Saint-Charles Avenue asks questions regarding: 1) transparency in the **drafting of the minutes** and certain items on the agenda; 2) the editing of the recording of a board meeting; and 3) **future real estate projects** in Dorval and the developers who will be involved in them.
- 13. A resident of Handfield Circle inquires about: 1) professional services for the preparation of plans and estimates for the **demolition and reconstruction** of the Dorval Aquatic and Sports Complex's roof; 2) authorization to sign applications for financial assistance within the framework of the City of Dorval's **greening program**; and 3) professional services for the drafting of a **new SPAIP by-law**.
- 14. A resident of chemin du Bord-du-Lac-Lakeshore asks questions regarding: 1) the drafting of a **new SPAIP by-law**; and 2) St-Charles Park and the impact of the work on the neighbourhood.
- 15. A resident of Montigny Avenue inquires about: 1) **public consultations**; 2) **bicycle lane delineators** on Dawson; and 3) street **markings**.
